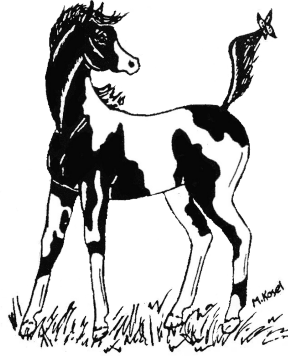

## **General Rules**

1. Open to any Pinto registered with the Pinto Horse Association of America, Inc. or **MUST** have conditional registration papers issued by a Field Rep by the date of the futurity. The Owner of the nominated Pinto must be a member in good standing of the PtHA on the date of the futurity, or all winnings will be forfeited. Copy of registration papers and membership cards for both PtHA and OPtHA must accompany nomination.
2. The OPtHA Futurity **WILL NOT** be Nationally pointed, but will run in accordance with the PtHA rules.
3. Payments shall be made in United States funds.
4. Nomination fees do not include show entry fees, drug fees, stall fee, etc.
5. All Entries in the Futurity must also enter at least one class in the regular scheduled show.
6. Entry must be made prior to the start of the first corresponding regular class (ie: a western pleasure futurity horse must enter the futurity before competition in any regular western pleasure class).
7. Substitution of horses is prohibited.
8. Nomination moneys will only be refunded upon death of the entered Pinto. A certified veterinarian death certificate must be delivered to the Futurity Chairman within 30 days of the death for refund. Office fees of 10% will be retained.
9. Nominations may be transferred upon sale of a nominated horse. The notice of sale and request for transfer must be received in writing before the horse is shown. A \$5.00 transfer fee must accompany each application.
10. A multiple judging system will be used for performance. Tie-breaker judges will be designated. If there is a tie, whichever Pinto the tie-breaker judges placed higher, will win the higher award. The monies for those places involved will be totaled and divided equally among those that are tied. There will be no exceptions to this ruling.
11. All Pintos may be asked to submit to laboratory testing. All results will be completed before moneys are paid. Any owner or handler refusing to submit a Pinto to testing will be disqualified with forfeiture of all awards. Any Pinto showing a positive lab test will be disqualified, with forfeiture of winnings.
12. A futurity entrant shall not be allowed to abuse or mistreat a horse in any manner on the show grounds. Such action shall be reported to the Futurity Committee and will be subject to disciplinary action by that committee or disqualification.
13. The show date will be determined by the Horse Show Committee and advertised by the Futurity Committee with the cooperation of the Publicity Committee.
14. **Bridles will be dropped for 2-3 year old Performance entries. Bits must conform to PtHA official Snaffle Bit or Driving Bit Rules.**
15. If a horse's mouth shows signs of broken skin, rawness, or bleeding, said horse or pony will be eliminated from competition forfeiting all entry monies. If a horse's nose or any other area touched by bosal shows signs of broken skin, rawness, or bleeding, the said horse will be eliminated from competition forfeiting all entry monies.
16. Cancellation of classes will be the decision of the Futurity Committee.
17. The decision to combine classes, when a class has 3 or fewer entries, lies solely with the Futurity Committee.
18. Any protest must be in written form and submitted to the Futurity Chairman within 12 hours according to the PtHA Official Handbook. There is a non-refundable 250.00 fee for each protest filed. The fee must accompany the protest. All protest which concern the Futurity will be decided by both the Show Committee and the Futurity Committee.
19. The right is reserved to reject any entry from competition for failure to comply with the rules.

20. In no event shall OPtHA, its officers, directors, agents or members be liable for actual, consequential or exemplary damages or for injury or damages to person or property that may occur at any OPtHA event. By making entry into any of the OPtHA events, any owner or exhibitor assumes the full risk of any injury or damage which may occur and agrees to abide by all of the OPtHA rules and regulations.

**Disbursements:**

21. Ten percent (10%) of all monies collected shall be withheld for ensuing futurity expenses, including, but not limited to: trophies, ribbons, and promotional expenses. The balance of the money will be paid back to the respective classes from which they were collected.

22. All futurity payments stay with the entry to appropriate class. For instance, if a nominated stallion is gelded, he is moved into the proper class and entry money moves with him. The same would be true if a type change is made.

23. All monies forfeited will go into the total money paid to the horses in that nomination class. If there are Pintos nominated and none show in the class, the entry money will be added to next year's futurity money.

24. Any added purse money from Sponsor will go to specified Futurity class.

25. All added money, unless specified for a certain class by the Sponsor, will be added into a class chosen by the Futurity Committee.

26. Following the Futurity Show, all results and monies won will be published online and in the October OPtHA Minutes which are also posted online.
