Treasury Report:

Show Committee:

Cascade Pinto shared class list with Tina Bell for use for October show. Discussion to modify All Breed divisions to 19 & Over and 18 & Under. Delany will correct class numbers.

Discussion whether to combine Mini A and Mini B Roadster. Decision to combine.

Add Youth Discipline Rail Driving Pony/Mini and Youth Reinsmanship Pony/Mini.

Utility Division: Need to add English Pleasure, Discipline Rail and Ideal for Utility High Point. Show committee will look into rules for Utility Division; may not be allowed to canter.

Leadline: Discussion to add English leadline. PtHAWW has trail, western, Halter, and does do a high point category. Entry fee is the regular pinto fee. Classes are pointed. Tina will look into Pinto rules for leadline classes. If we do a high point, will include Showmanship, English, Western, and Trail. Leadline must be 8 & under. English or Western. No ROM points. Year end certificates.

Club reviewed class list to make final changes as necessary.

Decision that timed events will be All Breed, not separated by Pinto.

Office manager will be Amber Cook. Discussion of additional show staff and fees. Still need in gate and second office person.

Tina will do stall charts, stall reservations, and RV spots.

Discussion of stall fees. Proposed charging \$130 for stalls for the weekend. Shavings at \$10 a bale for extra bales. Tina Bell motioned for stalls to be \$130 for show with 2 bags shavings or \$40/day for one day stall. Kathy T. second. Additional shavings at \$10 bag. Motion passes. \$25 post entry.
