Minutes of the January 6, 2015 meeting were read by Jean Howard, Secretary. Kathy Thomas noted that Brooke and Marissa Ervin are the 2015 Sweetheart Princesses in addition to Klair Thomas being Princess. Motion by Jessica Kimball, 2nd by Maridi Pletcher to accept minutes as corrected (name spellings/grammar format). Motion Passed.

Nominations and Special Election

Kathy Howe Drysdale noted that Maureen Weise had not attended 3 meetings in the prior year and was, therefore, not eligible to run for 1st Vice President. Cecelia Anderson withdrew her name from nomination.

Discussion was held regarding the bylaws for the special election. The bylaws posted on Oregon Pinto website are not the current bylaws. Changes were made and voted on at a general meeting in March 2014 which identified a **NEW** member as someone who had not been a paid member in good standing for the previous 2 years. A new member must have paid their dues 30 days prior to the special election in order to vote. A current member, identified as a member who was a paid member in good standing in the previous 2 years. A current member could pay their membership dues at the meeting and have voting privileges for the special election. Theresa Peltier ask that we move forward with the election based on the bylaws changed and voted on at the March 2014 meeting.

Motion by Theresa Peltier, 2nd by Sony Miller that ballots be counted in the open. Motion Passed. Wendy Davidson, PtHA President, Micheal McCarthy and Jayna Roberts counted the ballots. Results for the special election to seat the 1st and 2nd Vice Presidents are Kathy Howe Drysdale, 1st Vice President, Anne Monteith, 2nd Vice President.

Treasurer's Report

Mandy Lopes stated that she had resolved our Non Profit status with the State of Oregon by paying a \$100 fee. Mandy also noted that the club needed to tighten up with spending.

The balance in the checking account is \$11,563.80, balance in savings is \$4,627.06. Total balance of \$16,190.86.

The P & L will be completed by the next meeting.

A question was asked as to why a deposit was paid to Linn County Fairgrounds for the October show, but no deposit made for the April show. Tina Bell stated it was because someone else wanted our October dates so the deposit had to be made to secure them. A deposit for the April show needs to be made to secure those dates as well.

Discussion was held on the club credit cards. Cards need to be turned in by Tina Bell and Maridi Pletcher so that the changes can be made to the credit card holders and the signers for the checking account. A motion was made by Jessica Kimball, Cecelia Anderson, 2nd, that changes be made to the credit card holders and checking account signers. Motion passed. Mandy Lopes will take care of this.

Micheal McCarthy asked about the IRS issue. Per Mandy Lopes, she is still waiting on information from the IRS.

Committees/Reports

Sector Director

Discussion was held regarding the proposed rule changes for PtHA. Members were most concerned about allowing solid color miniatures to compete in miniature classes. The other rule that was a concern was requiring helmets and English attire in the hunter and jumper in hand classes.

Kathy Howe Drysdale asked about the Superior Charter award and the Charter Super Horse Awards. It is the first year that the Charter Super Horse is to be given. It is a free PtHA membership for the year. It will be given at the banquet per Tina Bell. The deadline for the Superior Charter was January 31st. We will look into applying for next year.

Wendy Davidson stated that area representatives at no longer called Sector Directors. They are now State Directors. Oregon has 2 director positions, Tina Bell and Terri Branham. Per Wendy Davidson, PtHA asks that directors pay their own way to the National meeting and not receive financial help from area clubs. Linda Enfield asked if we are ever going to be able to go back to 6 judge shows for PtHA. Wendy Davidson stated that it was unlikely in the near future.

Motion made by Micheal McCarthy, Kathy Howe Drysdale 2nd that we add a Communication Committee and that Alyson Foster be committee chairman. Motion Passed.

Old Business

Wendy Davidson took the floor to update Oregon Pinto members about the Pacific Coast Pinto Alliance. Oregon representative will be Tina Bell, Kathy Thomas and Kathy Howe Drysdale. Each sponsoring club will be responsible one day for food and refreshments for the judges. Also, each club is responsible for getting a \$200 sponsorship for the show. The show will be held August 26 – 30, 2015 at the Linn County Fairgrounds in Albany, Oregon. Kathy Howe Drysdale stated that OPtHA club members need to volunteer their time at this show because it is ours as well. Discussion was held on class list. Kathy Thomas stated at other clubs, if you want a special class, then you sponsor it.
