# TREASURER'S REPORT

There was approximately \$6700 profit from the October show. No NSF checks at this show. Treasury is up \$8000 from this time last year. Taxes are due next week and are almost complete. A glass blown necklace was donated to the club by Vickie Muney. The necklace has a \$282 value. IRS 2011 taxes not filed on time of approximately \$1100 is still being worked on by Mandy. The IRS continues to tell Mandy to keep trying as they do not have time to work on it. Motion by Jessica Kimball, 2<sup>nd</sup> by Deb Torpey to accept the report as presented. Motion passed.

Action Items still outstanding: Committee still needs to get with Kim to revamp website. Pat Berger, Lisa McCarthy and Ann Ebner are on the commitee. A question was asked about how much we paid for website maintenance? Per Mandy Lopes, last bill was \$320. Pat Berger would like to propose a change.

#### SHOW COMMITTEE

The Spring show made \$7368, and the Fall show made \$6722. At the spring show, there were 109 horses and 963 entries. There will be three shows produced by OPtHA in 2016. The dates will be April 22-24, July 29-31, Oct 28-30. OPtHA got bumped from the October show date by a dog show. RV spaces were affected. April and July show will be a full class list. The October show will be condensed with some more fun classes. OPtHA needs to show expenses on what it costs to put on a show. A question was asked about how many shows do members need to attend to qualify for year end awards. Currently, one produced and one approved by Oregon Pinto. Show rules need to be amended to two show produced by OPtHA. Discussion was held about approving outside shows. OPtHA does not get any monetary benefit from approving outside shows. Need to update show rules to 2 of the 3 shows produced by Oregon Pinto. Motion by Theresa Peltier, 2<sup>nd</sup> by Jessica Kimball to amend rule that a member must go to 2 shows produced OPtHA. Motion passed.

Discussion on approving outside shows. It was felt that it takes money from us, and is spent elsewhere. This amendment is for the 2016 show year. Change youth or amateur to all exhibitors. Motion by Jessica Kimball, 2<sup>nd</sup> by Pat Berger to change verbage from youth or amateur to "all exhibitors" The club purchased 26 poles for the trail course. Propose that we sell the poles in sets of 5 to barns and stables. The poles will be painted in their colors, but retain ownership. James Hickerson. will be painting them. Proposed fee would be \$60 for a set. Paint does this. Action Item: Ann Ebner will check for prices that other clubs charge. Theresa Peltier suggested that we paint them OPtHA colors, and then make a sign to display "sponsored by" for \$25. Kathy Howe Drysdale thanked everyone for all their help. Thanks to Kathy Howe Drysdale and Theresa Peltier for sponsoring the food in the evening. Chicken instead of the chilli feed.
