## March Spring Show 2024:

Show Manager: Kayla the March show was Cancelled. Refunds are coming. Most people have been understanding in waiting for refunds.

Loss: \$2426.83 for cancelling the show. \$1000.00 stayed with the facility. Everyone was super understanding. The judges want to come to the October show.

Kayla and Mike believe that cancelling the show was the right decision. We could have lost up to \$10,000.00 if we went ahead and held the show.

Discussion followed as to why our turnout for the show was low. We may have been competing against other shows.

Can we change the dates of our shows? Albany fairgrounds \$10,000.00 to hold a show. The fairgrounds have more RV Spots available. Having the stalls closer to the arena is always a draw. We must be careful about changing the dates so that we don't overlap with other clubs.

Wendy's stated Oregon used to hold a show in the first week of May. Cascade Pinto shows for 2025 are: May 16-19<sup>th</sup>, July 25-27 and October 10-12<sup>th</sup>. Her clients don't want to go to Salem. We need to get our show information out sooner rather than later for the website.

Mike will look for dates for 2025 in late April at the Albany Fairgrounds. Vicki to investigate getting information on the Eugene facility for available dates for 2025.

Fall Show 2024

Show Manager: Kayla will be happy to help but cannot manage the show. Maybe we have a show group, but we need to have a show manager as a contact person. Show committee DeAnne, Kayla, Mike, Sarah and Tina.
